MSU-Northern participates in the Western Undergraduate Exchange (WRGP) program. Students from any of the states listed at left are eligible to apply for a special, reduced tuition rate.

WRGP tuition rates are awarded to students who are fully accepted for admission and have completed the WRGP agreement and provided residency verification. Students need not demonstrate financial need to receive the WRGP tuition rate. WRGP tuition is awarded on a first-come-first-serve basis and is dependent on the following requirements:

- Continuous full-time enrollment during fall and spring semesters at MSU-Northern
- Maintenance of good academic standing
- Maintenance of permanent residency in qualifying state

Duration of the WRGP tuition rate is until completion of the program, provided that the student remains in good academic standing. If a student seeks to change his/her designated program, they will need to see the approval of MSU-Northern in order to determine the impact on their WRGP award. A student may not become a Montana resident for fee purposes while attending MSU-Northern as a WRGP student. The WRGP tuition rate cannot be used in conjunction with any other tuition waivers at MSU-Northern.

How To Apply:

- Complete the WRGP Agreement, sign and submit it, <u>along with verification</u> of your state residency (e.g., a copy of your driver's license or state issued <u>ID</u>), to MSU-Northern, Admissions Office, 213 Cowan Hall, P.O. Box 7751, Havre MT 59501 or fax it to (406)265-3792.
- Or complete the WRGP Agreement online at:
 https://www.msun.edu/admissions/graduate.aspx and upload verification of your state residency (e.g., a copy of your driver's license or state issued ID)
- Upon receipt of the WRGP application, MSU-Northern Admissions will review the document and residency verification. If all requirements are met, Admissions will update your residency status and apply the WRGP tuition.
