 the code rather than just run the code and make it work

 - Altering the existing language to something like this will make it clearer.
- The description for the second requirement doesn't specify what the "several disciplines" are.
- Make slight changes to the language to make it clearer due to possible future audits

Old Business:

- Academic Senate has been asked to nominate 5 individuals, making sure each college is represented with at least one and not more than two nominees.
 - Gary expressed a concern that the nominees should possibly be nominated through the colleges rather than Academic Senate. Concerns were addressed and it was decided Academic Senate would nominate representatives.
- Academic Senate will reach out to nominees before appointment.
- COHS will discuss whether a nominee from the college will work, due to low faculty numbers in the college (there are only four faculty members in COHS currently).
- Establish where we are now: three subcommittees 1, inventory of courses and expertise of our faculty to propose new opportunities. 2, looking at data (labor market, course completion) to see where opportunities are for student demand, and 3, how do we know that we are successful? How are we assessing?
- Academic Senate will email their nominations to get them in before the next Academic Senate meeting in November.
