Chancellor Kegel advised he participated in the 24<sup>th</sup> Annual Legends for Lights Pheasant Jamboree earlier this month. This organization gives millions to MSU-Northern in scholarships.

Chancellor Kegel shared MSU-Northern Foundation received a \$2 million scholarship donation, which makes are endowments close to \$20 million.
