Instructions for Direct Unsubsidized Loan Only Form

For the Financial Aid Office to be able to process your request to be considered for a Direct Unsubsidized Loan Only, you need to complete the page one form and provide a statement from your parent(s).

A statement can be handwritten or typed out, but it must include a physical signature from your parent(s) and the date that it was completed. A physical signature is completed in black ink or via a stylus on an electronic device; we cannot accept a typed name or cursive font as a signature.

If your parents are married, or living together, then they <u>both</u> need to confirm they will either refuse to contribute information to your 2024-2025 FAFSA or that they have ended all financial support. Please provide the completed statement with your completed form for review and to continue the process of your financial aid.

Your parent(s) can follow the wording of the following two examples. The Federal Government indicates that a parent can choose to either not be a contributor on the FAFSA or indicate that they do not provide any financial support to the student and will not provide any financial support to the student in the future.

Example Statements from parent(s) (*choose one):

- 1. I (full name of parent and spouse if married) am the parent(s) of (student's full, given name). I/we refuse to be a parent contributor on (student's name) FAFSA for 2024-2025.
